Our Mission:

The mission of Family Support & Resource Center is to make it possible for Dane County children and youth with disabilities to live at home with their families as valued and participating members of the community.

Disability affects families from all walks of life. The families we serve vary greatly in their circumstances, in their resources, and in their ability to cope with the extra responsibilities placed on them.

What families do have in common is the need for flexible and individualized assistance that will help keep them connected to their community, hopeful about the future, and supported in managing the extra stresses and expenses. Because disabilities are not typically cured and their impact often increases over time, most families we serve need long-term supports.

FSRC is guided by these principles -

- ♦ All children, including children with disabilities, benefit by growing up as a secure member of a family and sharing in positive, long-term relationships with other family members.
- Families have great capacity to care for children who have disabilities when they receive support from friends, neighbors, human service professionals, and other community members.
- Parents are generally in the best position to define their own needs, to find solutions, and to choose the kinds of services that will help them to care for their child with a disability.
- A sense of trust and confidence in the continuity of support is important to establish and preserve with each family.
- Communities are enriched when all people, including those with disabilities, are valued and included as full contributing members.

2023 Agency Highlights:

- The FSRC mission is to support families in raising their children at home. During 2023 no child supported by FSRC was removed from their home or moved to an out-of-home placement
- Staff resumed pre-Covid practices of screening children for functional eligibility, meeting with families face to face, disenrollment, and Medicaid reviews
- Significant work to transition 32 young adults from CLTS Waiver to Family Care, Partnership or IRIS
- Completed intakes for 56 children as part of statewide wait list elimination project
- Facilitated 23 major home and vehicle modifications to increase accessibility for children
- Successful annual CLTS record review by the Wisconsin Department of Health Services
- Staff participated in Dane County sponsored Case Management Symposium, Towards More Culturally Sensitive and Racially Just Children's Disability Services

Keeping All Children at Home with Their Families

Our Children's Long-Term Support (CLTS) Waiver Program provided ongoing services to 623 children in 2023, including 56 children who entered off the CLTS wait list. 25 CLTS children were dually supported through Comprehensive Community Services (CCS). 83 children and young adults were closed from the agency during the year:

- 32 young adults transitioned to adult services
- 23 children moved from Dane County
- 12 not functionally eligible
- Eight voluntarily closed
- Five transferred to another lead agency
- Two remained hospitalized
- One passed away

Children's Waiver staff work with families to:

- Understand and gain access to available resources
- Coordinate services, advocate for the child and facilitate teamwork and problem-solving
- Purchase needed goods and services not available through other funding sources
- Help families to build and strengthen networks of supports, to encourage friendships for their children, and to plan for the future

Waiting List Families

As of December 31, 2023, there were over 400 children on the CLTS waiting list in Dane County.

FSRC Programs Offer Choices, Flexibility & High Impact Assistance

Families in our CLTS Program have access to and choice among goods and services that are flexible and individually tailored to meet their needs. Families receive varying levels of case management time and financial assistance, based on their assessed desire for support.

Funds are received through various sources, including Dane County Department of Human Services, United Way, donors, and other funders. The majority of our funding is connected to the State Children's Community Options Program and the Children's Long Term Support (CLTS) Waiver Program. In 2023, total CLTS funds on Individual Services Plans were distributed within the following ranges:




Size of Grants

- 623 children received CLTS funding during 2023, the majority of funds were for services under contract with the Dane County Dept. of Human Services
- Total grant funding distributed directly through FSRC was \$225,794, primarily for recreation, adaptive equipment and medical supplies
- >99% of funding was CLTS Waiver, 1<% Children's COP

Family Subsidies

The chart reflects CLTS Waiver and Children's COP funds that were paid per Individual Service Plans for children supported through the Family Support and Resource Center. During 2023 the majority of funds were used for respite care, camp, equipment and supplies, home and van modifications, and training. Lesser amounts were utilized for transportation, recreation, therapy, and supportive home care.
